Dear Applicant:

Congratulations on your recent completion of law school and passing the North Carolina Bar Examination!

On behalf of the Young Lawyers Section of the Greensboro Bar Association, I welcome you to Guilford County, and I encourage you to become active in the Greensboro Bar Association and, more particularly, the Young Lawyers Section. The Young Lawyers Section is open to all attorneys who have been licensed within the last five years and/or who are under 40 years of age.

Each year the Young Lawyers Section sponsors a Swearing-In Ceremony for the admission of newly licensed attorneys to the state and federal courts. This ceremony is also open to newly licensed attorneys (who have already been admitted to state court and/or federal court) who simply want to participate in the ceremony and be introduced to the Greensboro Bar Association.

Due to COVID-19, this year's Swearing-In Ceremony will be held on October 29, 2021 at 3:00 p.m. on Zoom.

You are welcome to invite guests to join the Zoom ceremony; however, we ask that you be mindful of the number of participants allowed on a Zoom call and limit your invitations to a reasonable number of individuals. Please be aware that, depending on the number of new attorneys participating in the ceremony, it may become necessary for us to limit the number of guests that may participate in the Zoom ceremony. If such a limit becomes necessary, we will advise you of this as early as possible.

Our local judiciary requires that your certificate from the North Carolina Board of Law Examiners be present when you are sworn in. Therefore, you must have the actual certificate with you at the Swearing-In Ceremony. We strongly recommend that you not have your certificate framed until after you have been sworn in.

Accompanying this letter are the following materials for you to review and complete as soon as possible:

Exhibit A – Application for Swearing-In Ceremony – Complete and return ASAP to Tyler Nullmeyer (tnullmeyer@turningpointlit.com).

Please note that your sponsoring attorney must be a member in good standing of each Bar to which he or she is sponsoring you. This means that if you are seeking admission into state and federal court, your sponsor must have been admitted to practice in both state court and the

Middle District of North Carolina. Please inform your sponsoring attorney of the date, place, and time of the ceremony. We will e-mail your sponsoring attorney with a link to the Zoom meeting. Your sponsoring attorney will be given the opportunity to introduce you and give a short summary of your background. If you do not have a sponsoring attorney, a member of the Greensboro Young Lawyers Board will gladly sponsor you or help you find a sponsoring attorney (please indicate on the form if you need a sponsoring attorney). Please return this form to Tyler Nullmeyer (tnullmeyer@turningpointlit.com) no later than Tuesday, October 26, 2021.

Box 3525, Greensboro, N.C. 27401 (mail) or 114 N. Elm Street, Suite 600, Greensboro, NC 27401 (hand delivery).

If you desire to be sworn into State Court, please complete this form in type, and mail or hand deliver two (2) copies of the Oath with your original signature to Nicole Scallon at Henson & Talley, LLP P.O. Box 3525, Greensboro, N.C. 27401 (mail) or 114 N. Elm Street, Suite 600, Greensboro, NC 27401 (hand delivery) no later than Tuesday, October 26, 2021 (if you mail the copies of the Oath, please ensure they will be delivered by Tuesday, October 26, 2021). The Young Lawyers Section will submit the Oaths to the Clerk of Superior Court PRIOR to the virtual ceremony and the original Oaths will be signed by the Judge and filed with the Clerk of Superior Court AFTER the Swearing-In Ceremony. An additional conformed copy should be retained for your records. There is no charge for admission to the State Courts.

Exhibit D – Application for Admission to Practice in the United States District Court for the Middle District of North Carolina – Please complete this application in duplicate and mail the two copies to “United States District Court 324 W. Market Street Greensboro, NC 27401 Attn: Attorney Admissions Clerk” along with the \$188 fee prior to the ceremony.

This application must be completed in duplicate. The Clerk will file the original after the ceremony and will return the other copy for your records. The Federal Court admission fee is \$188.00. Please mail a \$188 check payable to “Clerk, U.S. District Court,” along with the two (2) completed application forms, to United States District Court 324 W. Market Street Greensboro, NC 27401 Attn: Attorney Admissions Clerk. The Clerk must receive your fee and application forms prior to the October 29, 2021 ceremony.

You will notice on this form that you must certify that you have read and are familiar with the Federal Rules of Civil Procedure, the Federal Rules of Criminal Procedure, the Federal Rules of Evidence, the Rules of Practice and Procedure for the United States District Court for the Middle District of North Carolina (known as the “Local Rules”), and the North Carolina

Code of Professional Responsibility. A copy of the Local Rules is available at www.ncmd.uscourts.gov/court-info/local-rules-and-orders.

Exhibit E – Greensboro Bar Association Benefits – Return with fee to GBA.

Memorandum to Persons Requesting Admission to the Bar

TO: PERSONS WHO ARE REQUESTING ADMISSION TO THE BAR AT
THE GREENSBORO BAR ASSOCIATION OCTOBER CEREMONY

In order to be sworn in to the state and federal court, you need to do the following things:

1. A lawyer licensed to practice in North Carolina must move the Court for your admission to practice. This individual is commonly referred to as your “sponsor.” If you have a sponsor, that individual must virtually attend the Swearing-In Ceremony. Your sponsoring attorney must be a member in good standing of each Bar to which he or she is sponsoring you. **This means that if you are seeking admission into state and federal court, your sponsor must have been sworn into both state court and the Middle District of North Carolina.** If you do not have a sponsor, you must indicate this on your Application for the Swearing-In Ceremony so that the Young Lawyers Section can be sure to provide you with a sponsor.
2. Complete the Application for Swearing-In Ceremony and return it to Tyler Nullmeyer by **Tuesday, October 26, 2021** at tnullmeyer@turningpointlit.com.
3. To be sworn in and admitted to State Court, **mail or hand deliver two (2) signed copies** of the Oath (included herein as Exhibit C) with **everything filled in and signed except the Judge’s signature to Nicole Scallon at Henson & Talley, LLP P.O. Box 3525, Greensboro, N.C. 27401 (mail) or 114 N. Elm Street, Suite 600, Greensboro, NC 27401 (hand delivery)** by **Tuesday, October 26, 2021**. The Young Lawyers Section Board will submit the Oaths to the Clerk prior to the ceremony. After the oath is administered during the virtual Swearing-In Ceremony, the oaths will be signed by the judge and one oath will remain with the Clerk.
4. To be sworn in and admitted to Federal Court, **mail two (2) copies** of the **Application** and a **check for the \$188 fee (payable to “Clerk, U.S. District Court”)** to **United States District Court 324 W. Market Street Greensboro, NC 27401 Attn: Attorney Admissions Clerk**. The Clerk **must receive Application and the fee payment PRIOR to the date of the Swearing-In Ceremony**, October 29, 2021. After the Swearing-In Ceremony, one application will remain with the Clerk and one application and the receipt for the fee payment will be returned to you for your records.

Have your law license available during the virtual ceremony. Yes, we really mean for you to have the big fancy piece of paper you are going to have framed available on Zoom. It must be shown to the presiding judge before he/she will sign the Oath and Order of Admission. If you have not received your law license by October 26, 2021, please contact Tyler Nullmeyer immediately at tnullmeyer@turningpointlit.com.

ATTORNEY ADMISSION - GENERAL INFORMATION

Applicable Local Rules: The rules of governing admission to practice are set forth in Rule 83.1(b) of the Local Rules of the Middle District of North Carolina. A copy of the Local Rules is provided free of charge to newly admitted attorneys. Additional copies may be downloaded from the Middle District of North Carolina's internet site, www.ncmd.uscourts.gov, and are available at the intake area of the Clerk's Office.

Requirements for Admission: There are two Options for admission:

Option I - If you have never been admitted to the United States District Court in the Eastern or Western District of North Carolina, you must appear in open court in this district to take the oath. Complete the admission form through the Option I section, then place your signature and date under the Oath before returning the form to the Clerk's Office. This certifies that you have met the requirements for admission. A similar oath will be administered in open court. A receipt and the original copy of the Application for Admission to Practice will be returned to you. When you appear to take the oath, please appear with the attorney that will be moving for your admission and present to the courtroom deputy the original copy of this form, the receipt showing that the admission fee has been paid, and your membership card in the North Carolina State Bar.

Option II - If you have been admitted to the United States District Court in the Eastern or Western District of North Carolina, complete the form, leaving blank the Option I section. You must complete the Option II section and then place your signature and date under the Oath before returning the form to the Clerk's Office. Upon receipt of your application, accompanied by a photocopy of your Certificate of Admission (or an original Certificate of Good Standing) from the Eastern or Western District, a Certificate of Admission to practice in the Middle District of North Carolina will be mailed to you.

Filing Application for Admission: For either option, the form must be completed in duplicate and submitted to the Clerk's Office along with a check for \$188.00, made payable to "Clerk, U. S. District Court." Mail the completed admission form, check, and if applicable - your photocopy of the Admission Certificate of the other District - to:
