I have been in Guilford County since I first arrived here in the Fall of 1999 to attend North Carolina A&T State University. Even though I was born and raised in Gaston County, North Carolina, I became an adult here in Guilford County, and I consider it a true home away from home. I received my Bachelor of Science degree in Economics in the Spring of 2003, and left Guilford County in 2004 to begin my journey to become the attorney that I am today. I attended the North Carolina Central University School of Law, and earned my Juris Doctor degree in the Spring of 2007. I promptly returned to Guilford County where I worked as an associate attorney with the law firm of Gray, Newell, Johnson and Blackmon, LLP. I then obtained a position with the Guilford County Public Defender's Office where I worked under the late Wallace Harrelson and Frederick Lind for more than four years. In my capacity as an assistant public defender, I was entrusted with a very large number of criminal cases, and I tried and disposed of matters ranging from misdemeanors in district court to felonies in superior court.

In 2012, I accepted a position with The Montgomery & Haley Law Firm, PLLC in Mecklenburg County, North Carolina. In my capacity as associate attorney with The Montgomery & Haley Law Firm, I had the pleasure of assisting with and disposing of both civil and criminal matters in twenty-three (23) counties, stemming as far west as Cleveland County and as far east as Wake County. I also assisted in the disposal of matters in South Carolina. I subsequently decided to return to Guilford County, my home away from home, to open my own firm. In September 2013, the Law Offices of Brenton J. Boyce, PA was officially open for business. Returning to Guilford County has been the most rewarding career decision that I have made.
